12 REPORTS OF MEMBERS OF COUNCIL

12.1 Councillor Daniel Sutton

- Day Care Ad Hoc Committee Meeting – February 29th, 2016
 - The Committee met to review use of the extended hours at the Day Care. There are a number of families that have been utilizing the service which is good to see. Since the extension of hours has been implemented Council members have noted that there have not been any more complaints about access to services.
- Kenora District Services Board (KDSB)
 - Provided information on his follow-up with KDSB regarding the funding available for Resource Teacher training. KDSB advised that funding has never been made available for Resource Teacher workshops.
 - Also advised that he had received some public inquiries about the availability of Social Housing and the information that KDSB provided on the waiting list and available units was unclear. Additional information has been requested.

12.2 Councillor Rob Eady

- Chukuni Communities Development Corporation (CCDC)
 - The broadband project has been signed off by the CCDC as the Ear Falls portion of the project has now been addressed. Councillor Eady advised that some upgrades have already been completed in the community and an additional upgrade is planned to improve service for the built-up area of Ear Falls. These upgrades will not impact service in the rural area of the

Township.

- Cathy Quesnel offered to attend the Community and Economic Development Committee Meetings in a guidance capacity.
- Previously reported that there was \$15,000 available for Ear Falls community projects, such as signage, but noted there have been reductions to this amount since it was initially made available. Current funding available is \$9,259.

12.3 Councillor Tracey Simon

- Ontario Good Roads Association (OGRA) Conference
 - Provided a written report to Council regarding her participation at the OGRA Conference.
 - Noted that participation in the Small Town Forum at the Conference was quite good. This forum was a good opportunity to network with other people in similar situations. Many small communities are experiencing the same problems as Ear Falls, such as youth leaving communities, aging infrastructure, and economic development. Unfortunately there were a lot of problems in common but disappointingly not many positive solutions.

12.4 Mayor Kevin Kahoot

- Ontario Good Roads Association (OGRA) Conference
 - Meetings with Ministers were very good.
 - Minister Gravelle, Ministry of Northern Development, Mines, was very interested in working with the Township, particularly on the Water Intake project. Another meeting with Minister Gravelle is being planned.
 - Minister Oraziotti, Ministry of Government and Consumer Services – discussed the Township’s proposal for ServiceOntario and emphasized that the Township’s Proposal is contingent on the province funding the service.
 - Minister Mauro, Ministry of Natural Resources and Forestry – discussed the changes to the Moose Hunting Regulations and the impact that this is having in the community and the region. Also discussed Cottage Lot Development and the way that municipalities are turning this over to developers to complete the process. Under this process municipalities do not receive any revenue in the sale of land. They see revenue from subsequent taxation of the developed parcels.
- Northwestern Ontario Municipal Association (NOMA) Meeting at the OGRA Conference
 - Met with seven ministers at the NOMA Meeting and provided Council with the NOMA presentation information for their perusal.
- Met with Mayor Wilson, City of Dryden to discuss operations and some challenges that they are facing.
- Scotiabank Economist presentation

- Extremely interesting information on commodity pricing and the impact that exports have on the Canadian economy. In particular there has been a significant impact on the fuel and oil industry. She projected that gold prices would rebound over the next eight months with ongoing increases over the next two to three years. Global economic trends looked good but Canadian economic trends look very good.
